## 04月26日: VN-Index supported by favorable stocks (VN-Index +0.38%)

- VN-Index opened today's trading lower than yesterday's close.
- It temporarily fell below the psychological line of 1,200 pt at the end of the ATO session, but from there, the index began to move higher on increased buying interest.
- In the afternoon, the market remained flat around the base price, but eventually rallied mainly on stocks with favorable earnings results.
- The market breadth included 209 winners, 227 losers and 97 unchanged.
- Liquidity increased 9.1% from yesterday to VND15.4 trillion.

## VN-30 leads gains (VN-30 +0.55%)

- The basket included 13 increasing stocks, 13 decreasing stocks, and 4 staying the same.
- VIC (+5.83%), HDB (+4.89%), and SHB (+3.15%) contributed to the gains.
- MSN (-1.32%), STB (-0.88%), and BID (-0.81%) were the main decliners.

## Sectors and stocks daily highlights

HDB (+4.89%) held its 2024 Annual General Meeting of Shareholders today, setting a pre-tax profit target of VND15.852 trillion (+21.8% over 2023 actual) for its 2024 business plan. The dividend payout ratio for 2024 is planned to be 30%.

- VIC (+5.83%) announced its financial results for the first quarter of 2024.
   Consolidated sales were VND21.739 trillion (-44% YoY) and after-tax profit was VND1.335 trillion (+126% YoY).
- Foreign investors turned to net buy VND110 billion, with MWG (+2.04%)
  notable for net bought, while FUEVFVND (+2.50%) was notable for net
  sold.
