



## DAILY NEWS – 11/03/2026

### VN-Index maintained strong gains (VN-Index +3.08%)

- VN-Index opened slightly higher with mixed performance across sectors.
- Investor sentiment remained cautious as trading volume did not rise in line with the index, though the number of advancing stocks continued to increase.
- The rally held firm toward the close, supported by broad recovery in Real Estate, Industrials, and Consumer sectors.
- Market breadth recorded 291 advancers, 57 decliners, and 35 unchanged stocks.
- Liquidity fell 29.3% to VND 29.5 trillion.

### VN30 extended its rally (VN30 +2.88%)

- The basket recorded 28 gainers, 1 decliner, and 1 unchanged stock.
- VPL (+6.99%), GVR (+6.90%), and MSN (+6.88%) hit their daily upper limits.
- BID (-0.24%) was the only decliner.

### Sectors and stocks daily highlights

- SHB (+1.72%) approved the list of professional investors participating in its private placement of 200 million shares, expected to raise about VND 3.37 trillion to support credit growth.
- F88 (+11.46%) announced its 2026 business plan, targeting consolidated pre-tax profit of VND 1.13 trillion (+25% YoY) and revenue of VND 5.46 trillion (+42% YoY).
- Foreign investors recorded net buying of VND 1,086 billion today. MWG (+6.79%) led net inflows, while STB (+2.00%) and SSI (+2.02%) saw the largest net selling.
