VN-Index reclaimed the 1,700 level (VN-Index +1.01%)

- VN-Index started high above the reference mark, backed by the gains of Banking and Financial Services sectors, as well as strong cash flow.
- Although the upbeat cashflow somewhat cool down, the market maintained a high level in the morning as the positivity spread to Real Estate sector.
- Pressures from Oil & Gas sector due to stabilizing oil prices pulled the market back slightly in the afternoon.
- Market breadth included 179 winners, 147 losers and 54 unchanged.
- Liquidity improved by 10.4% to VND 25.5 trillion.

VN30 was widely green (VN30 +1.11%)

- The basket recorded 23 increasing stocks, 6 decreasing stocks and 1 staying the same.
- Largest gainers included VCB (+2.89%), LPB (+3.21%), MWG (+2.61%).
- DGC (-6.90%) hit floor price, followed by PLX (-2.25%) and GAS (-1.71%).

Sectors and stocks daily highlights

- The plunge of DGC (-6.90%) came after the chairman of the company was prosecuted due to violation of accounting regulations, violation of resource exploitation, and causing environmental pollution.
- MSN (+2.59%) and MCH (+6.94%) increased after WCM recorded a significant jump in revenue to VND 7,872 billion (+32.2% YoY) in 2M2026.
- Foreign investors continued to net sell VND 671 billion today. Net selling focused primarily on VIC (+1.04%). On the other hand, VCK (+6.89%) and MCH (+6.94%) were the most net bought stocks.
