VN-Index surged amidst positive tailwinds (VN-Index +4.71%)

- VN-Index started high above the reference mark after FTSE Russell officially upgraded Vietnam to Secondary Emerging Market.
- Buying forces were strong and spread market-wide, keeping the index at a high level throughout the morning.
- Market sentiment was further strengthened by the de-escalation between U.S and Iran, and the market gradually climbed up in the afternoon.
- Market breadth included 322 winners, 27 losers and 26 unchanged.
- Liquidity also surged by 129.6% to VND 34.9 trillion.

VN30 was overwhelmingly green (VN30 +4.89%)

- The basket recorded 29 increasing stocks and 1 decreasing stock.
- Multiple stocks touched ceiling prices such as FPT (+6.89%), SSI (+6.91%), STB (+6.97%), TCB (+6.97%).
- LPB (-1.04%) was the only decliner.

Sectors and stocks daily highlights

- Rubber producers GVR (+5.40%), PHR (+4.13%), TRC (+1.55%) jumped as rubber export increased notably toward the end of 1Q2026.
- DGW (+6.52%) announced positive revenue for 1Q2026 at VND 8,595 billion (+56% YoY), completing 27% of the annual target.
- Foreign investors net sold VND 613 billion today. VIC (-6.97%) was the primary focus of net selling force. On the other hand, HPG (+4.48%) and FPT (+6.89%) were the most net bought stocks.
